#### **POSITION PURPOSE:**

This US Multi-Disciplinary Team (MDT) Coordinator position advances the mission of Lifesong through coordinating US MDT projects and initiatives, assisting the US MDT in scheduling ongoing support or training for international local MDTs or ministry sites, and collecting orphaned and vulnerable children (OVC) ministry assessments and outcome reports and creating reports for Lifesong leadership.

#### PRIMARY RESPONSIBILITIES AND DUTIES:

- Coordinate MDT projects and initiatives
  - · Schedule and facilitate regular MDT meetings
  - · Update and organize MDT taskers with clear objectives and timelines
  - Serve as administrator of the shared online MDT workspaces such as a Microsoft Team or SharePoint sites
  - · Organize and maintain shared MDT documents and training materials
  - Manage any US MDT shared e-mail inbox and coordinate any mass US MDT communications
  - · Know and champion all Lifesong policies that touch the work of the US MDT
  - Assist with safeguarding incident response process, ensuring confidential handling, documentation, and reporting per organizational and legal requirements
- Assist the US MDT in scheduling ongoing support or training for international local MDTs or ministry sites
  - · Manage database of ministry site contacts and global MDT members
  - · Schedule support meetings and trainings with ministry site leaders or global MDTs
  - Attend assigned in-person or virtual US sponsored MDT support meetings or trainings for relational, technical, or other types of assistance
  - · Assist in delivering safeguarding policy training for staff and partners, as needed
- Collect OVC ministry assessments and outcome measurements such as: API (Assess, Plan, Implement), 4PP (4-Part Pledge), Outcome Reports (Year End Outcomes), etc. and create reports for US MDT and Lifesong leadership

- · Research best practices and tools for API and continuous improvement
- · Miscellaneous Duties: performs other duties, as assigned

## **REQUIRED SKILLS:**

- Passionate commitment to Lifesong's Core Focus
- Team-oriented with strong interpersonal communications skills to address sensitive issues, train, and build trust with partners
- · The ability to be sensitive to and aware of intercultural dynamics within diverse teams
- Strong focus on detail to ensure policy compliance with policies and thorough documentation
- · Ability to manage the emotional demands of sensitive cases and manage personal impact
- Growing subject matter expertise in one or more of the four OVC responsibilities of the 4-Part Pledge (discipleship, child care, education, transition)
